# WHAT IS CONNECT?

## The Purpose

Flint Hills - Fort Riley **CONNECT** is a public education and communication resource for residents, landowners, and other stakeholders within Fort Riley and the surrounding community. This document aims to facilitate **EDUCATION** and **COMMUNICATION**. **CONNECT** highlights key topics that emerge in Fort Riley's relationship with its neighbors and facilitates *communication* by distributing important contacts and connection points within Fort Riley and the surrounding communities. FHRC will update the manual yearly, supported by Fort Riley, Clay, Geary, Pottawatomie, and Riley counties and the towns of Chapman, Grandview Plaza, Herington, Junction City, Manhattan, Milford, Ogden, Riley, and Wakefield.

## The Vision

These resources bolster recommendations presented in the [Flint Hills/Fort Riley Joint Land Use Study \(JLUS\)](#). The JLUS is the outcome of collaborative planning among Fort Riley representatives and the local governments of: Clay, Geary and Riley Counties, and the towns of Grandview Plaza, Junction City, Manhattan, Milford, Ogden, Wakefield, and Riley. The Study was undertaken to increase awareness of relevant growth and development plans, highlight issues around Fort Riley, and ensure growth compatible with military operations.

## The Support

Flint Hills - Fort Riley **CONNECT** was made possible by the United States Office of Local Defense Community Cooperation (OLDCC)'s Compatible Use and Installation Resilience Grant. Compatible use and installation resilience efforts are designed to establish or reinforce an ecosystem of self-sufficient, cooperative civilian and military relationships that

# WHO IS INVOLVED?

## Office of Local Defense Community Cooperation

The U.S. Department of Defense Office of Local Defense Community Cooperation (OLDCC) furthers the priorities of the National Defense Strategy by supporting the readiness and resiliency of military installations and defense communities across the country. OLDCC helps states and communities strengthen critical relationships with Department of Defense's assets and installations through grant-funded activities are eligibility-based, needs-based, and customer-driven.

## Fort Riley

Fort Riley has been the heart of the Flint Hills region for more than 160 years. Established in 1853, the Fort was an outpost to protect westward travelers on the Oregon-California and Santa Fe trails. The 1st Infantry Division, the first permanent division in the U.S. Army and the oldest continuously serving division, known as "The Big Red One", was founded in 1917.

Today, the 100,000-acre facility employs innovative training to serve its approximately 15,000 active-duty serve members. An estimated 18,000 family members, 29,000 veterans and retirees, and 5,600 civilian employees live in the region. Thus, the Fort, as the largest employer in the region, is closely tied with the local community. Its full economic impact is estimated to be nearly \$3.5 billion.

## Flint Hills Regional Council

The Flint Hills Regional Council (FHRC) is a non-profit, voluntary service association of local Kansas governments that provides services of mutual benefit to the region with the goal of enhancing economic vitality and improving quality of life throughout the Flint Hills. FHRC collaborates with local governments, agencies, and residents, including Fort Riley who is an ex-officio member of the FHRC. The relationship between Fort Riley and FHRC has resulted in several JLUS implementation projects including a Military Installation Resiliency Study, Housing Assessment for Junction City , and more that can be found on [FHRC's website](#).

# EDUCATION

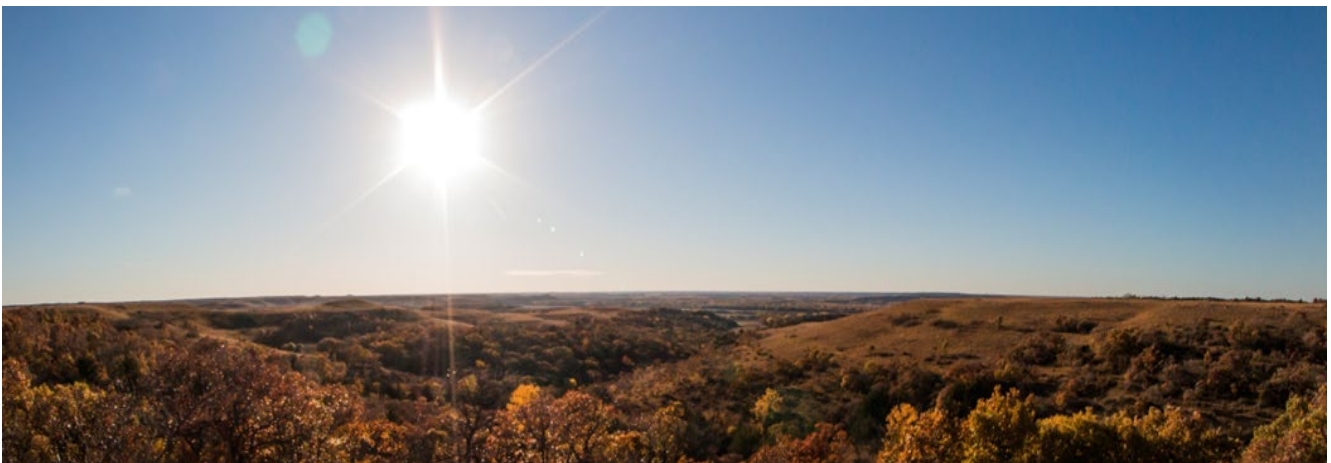
Education on unique concerns within military communities is desired for Fort Riley and its neighbors. Fort Riley has created various [educational publications](#) including regular economic impact summaries and a [2030 Strategic Plan](#). In the JLUS, education on environmental impacts arose as an area of specific concern. The noise impact of military training and the natural environmental impacts of development in Fort Riley and the surrounding communities have both been explored within various Fort Riley and FHRC-created resources. There is, however, still opportunity for growth in environmental programs.



## Noise Impact of Training

Fort Riley regularly trains over 30,000 soldiers. These activities predominately include live-fire exercises and vehicle maneuvering training. During live-fire training, every weapons system in a heavy artillery division's inventory may be fired. Such noise pollution may be a concern to surrounding community members and landowners. In response, several noise-related resources are offered by Fort Riley and FHRC:

## Natural Environment Impact

As Fort Riley trains thousands of soldiers, they desire to prioritize environmental protection for the longevity of their operations, health and safety of surrounding communities, and the preservation of valuable natural ecosystems. Fort Riley has established specific environmental protection policies within their [Integrated Natural Resources Management Plan](#). They also promote environmental protection through their internal Environmental Division and external partnerships.

## Fort Riley Environmental Division

Fort Riley's Environmental Division focuses on integrating environmental management with operations and realistic training conditions to enhance the installation's current mission while

creating opportunities for future training. The division specifically commits to conservation and pollution prevention through their two branches:

## Opportunities for Growth

### Fire Prevention Efforts

The Flint Hills' native tallgrass prairie is one of the most endangered ecosystems in the world, making fire prevention crucial. Today, as the tallgrass prairie supports cattle ranching, prescribed burning provides fresh grass and prevents the growth of encroaching species. For this reason, measures like [Flint Hills Smoke Management Plan](#) have been implemented to guide prescribed burns and minimize the air impact in downwind communities.

Fort Riley must take special care to ensure their military operations do not create fire hazards. Thus, Fort Riley fire & emergency services as well as public education programs are in place.

### Fort Riley Fire and Emergency Services

[Fort Riley Fire and Emergency Services](#) responds to natural or man-made disasters, provides emergency medical care, and reinforces education through prevention efforts and involvement in the Flint Hills Region. Fort Riley has five fire stations and a fire inspection department. The Fire and Emergency Services webpage contains publications regarding fire safety inspection, emergency contacts, fire warden responsibilities, and the current [Fire Prevention Protection Program](#). The Fort Riley Podcast featured a [special fire prevention episode](#) for fire prevention week. The podcast is an example of how Fort Riley and the surrounding community can use various technological platforms to educate the public about fire risks and available services.





## Dark Sky Program

With recent urban development, light intensity has significantly increased around Manhattan, Junction City, Grandview Plaza, and the cantonment area of Fort Riley. Design standards and dark sky lighting requirements can aid in standardizing practices for light pollution reduction.

These standards, such as a Vertical Obstructions MIA, and Dark Sky Lighting requirements can be adopted by Fort Riley and surrounding communities to minimize urban sky glow and light trespassing into adjacent properties. The Vertical Obstructions MIA prevents vertical obstructions in the areas underlying flight paths, flight training routes, and UAS flight corridors utilized by Fort Riley. Dark Sky lighting requirements can be incorporated into local zoning regulations and building codes of communities that fall within the flight paths of MAAF and helicopter training routes.

## Readiness and Environmental Protection Integration (REPI) Program

The REPI Program preserves military missions by limiting or alleviating encroachment threats (such as increasingly common and extreme natural disasters) that could affect Department of Defense (DoD) installations. Fort Riley has the only current REPI program in Kansas.

The REPI benefits Fort Riley by:

- protecting training that produces significant noise or light pollution such as live-fire artillery, ground vehicle maneuver, helicopter, and night flying
- preventing the loss of training days
- providing for mission growth

The REPI benefits the surrounding community by:

- protecting working lands and local character, thus benefiting the economy
- supporting existing regional planning efforts like the JLUS to better coordinate planning among government entities

As of September 2021, 15,962 acres were preserved through the REPI program. This positive trajectory can continue by regularly revisiting and implementing REPI recommendations for Fort Riley such as described in this [project profile](#).

# COMMUNICATION

Communication is key for a healthy relationship between Fort Riley and its neighbors. Therefore, Fort Riley contact information, social media, and visitor access information are provided. And, in response to the JLUS, FHRC has facilitated avenues in which the public can express questions and concerns about Fort Riley-related issues which are described below. 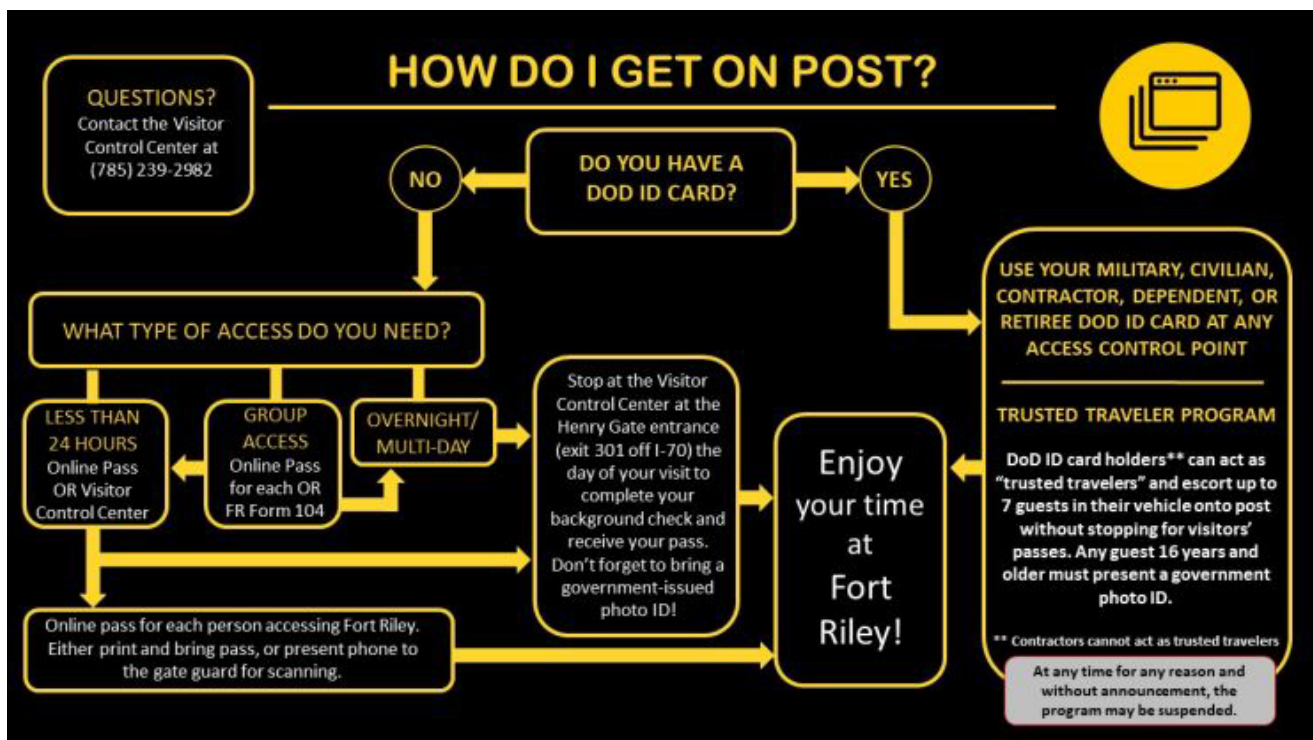

### Gates

Fort Riley has six operating access gates. Henry Gate, the main gate, located at Exit 301 off U.S. I-70, is open 24 hours daily and is the location of the Visitor Control Center (DES).

### DOD ID

DOD ID card holders have access to any gate and can act as “trusted travelers” to escort up to seven guests, with government photo ID, without stopping for visitors’ passes.

### Visitor Passes

Visitors to Fort Riley can now apply for [single-day](#) or [group access](#) passes online. These passes are sent via email and may be requested by anyone with a valid driver’s license. It is recommended that visitors submit pass applications 24 hours in advance of their visit.

Visitors to Fort Riley looking for overnight or multi-day passes must stop at the Visitor Control Center at the Henry Gate entrance to complete a background check before receiving a pass. Temporary closures or temporary gate locations may be put in place due to construction. For such information, follow Fort Riley and the Fort Riley PAO on social media.
